Introduction

Literature review

Research methodology

The methodology section should be detailed and include a description of the proposed research method and a justification for its selection. Planned details of the research sample, such as size, selection and characteristics, should be provided, and the anticipated data collection procedures, such as surveys, interviews or experiments, should be described. It is also important to present the planned data analysis methods, such as statistical analysis techniques, analytical tools, qualitative analysis, etc.

Results

(1) The results section should include a presentation of the main results of the study in an organized and understandable manner. It is useful to use tables, charts and graphs to illustrate the data and to discuss in detail the trends and patterns observed.

(2) The expected results section should include general predictions of expected results. The discussion should present the potential implications of the results in the context of the research question and the existing literature.

Discussion

The discussion should interpret the results (intended outcomes) in the context of the hypotheses or research question and the existing literature. You need to point out the theoretical and practical implications of the research results, compare the obtained results with previous studies and discuss possible differences (present both expected results and possible / probable deviations / exceptions / new possibilities, etc.).

Summary

The article summary should briefly present the main results of the research. The main theoretical and practical implications should be pointed out, and the importance of the research to the field of science should be emphasized. Limitations of the research should also be pointed out and directions for further research should be proposed.

This could include relevant industry trends, challenges or opportunities that form the backdrop to the situation being analyzed. And again, the organization's motivation for taking action

Undertaken actions

According to the BPM Case Studies standard, describe what was done, how it was done, what the constraints were.

Results

Present the key findings, results, or insights that will be analyzed in the case study. This will help engage the reader and set expectations for what they can learn from the analysis.

Theoretical, practical, and social implications

Explain why the case study is important. Discuss how it contributes to understanding broader industry trends, management practices, or relevant academic concepts.

Summary
